

**BOARD BILL NO. 111      INTRODUCED BY ALDERMEN KENNETH ORTMANN,  
CRAIG SCHMID, JENNIFER FLORIDA**

1            An ordinance authorizing and directing the Director of Streets to temporarily close,  
2            barricade or otherwise impede the flow of traffic various streets in the Ninth, Twentieth and  
3            Fifteen Wards and containing an emergency clause.

4            **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

5            SECTION ONE: The Director of Streets is hereby authorized to temporarily close and  
6            barricade, for a period of six months, South Compton Avenue at the south curblineline of Osage  
7            Street.

8            SECTION TWO: The Director of Streets is hereby authorized to temporarily close and  
9            barricade, for a period of six months, South Compton Avenue at the north curblineline of Gasconade  
10           Street.

11           SECTION THREE: The Director of Streets is hereby authorized to temporarily close  
12           and barricade, for a period of six months, Osage Street at the west curblineline of South Broadway.

13           SECTION FOUR: The Director of Streets is hereby authorized to temporarily close and  
14           barricade, for a period of six months, Ohio Avenue at the south curblineline Gasconade Street.

15           SECTION FIVE: The Director of Streets is hereby authorized to temporarily close and  
16           barricade, for a period of six months, Pennsylvania Avenue at the south curblineline of Wyoming  
17           Street.

18           SECTION SIX: The Director of Streets is hereby authorized to temporarily close and  
19           barricade, for a period of six months, Nebraska Avenue at the north curblineline of Juniata Street.

1 SECTION SEVEN: The Director of Streets is hereby authorized to temporarily close  
2 and barricade, for a period of six months, Ohio Avenue at the south curblineline of Arsenal Street.

3 SECTION EIGHT: The Director of Streets is hereby authorized to temporarily close and  
4 barricade, for a period of six months, Texas Avenue at the south curblineline of Gravios.

5 SECTION NINE: The Director of Streets is hereby authorized to temporarily close and  
6 barricade, for a period of six months, Pestalozzi Avenue at the east curblineline of California Street.

7 SECTION TEN: The Director of Streets is hereby authorized to temporarily close and  
8 barricade, for a period of six months, Juniata Street at the east curblineline of Minnesota Avenue.

9 SECTION ELEVEN: The Director of Streets is hereby authorized to temporarily close  
10 and barricade, for a period of six months, Winnebago Street at the east curblineline of the north-  
11 south alley west of Jefferson Boulevard.

12 SECTION TWELVE: The Director of Streets is hereby authorized to temporarily close  
13 and barricade, for a period of six months, California Avenue at the north curblineline of the east-west  
14 alley north of Chippewa Street.

15 SECTION THIRTEEN. Emergency Clause. This being an ordinance for the preservation  
16 of public peace, health and safety, it is hereby declared to be an emergency measure within the  
17 meaning of Sections 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore  
18 this ordinance shall become effective immediately upon its passage and approval by the Mayor.
